### SWISS CHALET'S FESTIVE SCRATCH & WIN CONTEST 2025

#### **FULL RULES & REGULATIONS**

- **1. PROMOTION PERIOD:** The Swiss Chalet Festive Scratch & Win Contest (the "**Promotion**") starts at 12:00:01 a.m. Eastern Time (ET) on Friday, November 1, 2025 and is scheduled to end at 11:59:59 p.m. ET on Sunday, December 28, 2025 or whenever official game cards are exhausted, whichever occurs first (the "**Promotion Period**").

Any attempt to undermine the legitimate operation of this Promotion is a violation of criminal and civil laws and should such an attempt be made, the Sponsor

reserves the right to seek remedies and damages to the fullest extent permitted by law.
